# Animal policy and by law - Proposal for change on Island Bay beach

Wellington City Council has a proposal to move dog exercise area to the East side of the beach.

Laurie apologised for any perceived lack of communication. The origin of the proposal is concern for restoration of dunes and native grasses. Concern that dogs are having a negative impact on regeneration. But the Council has been unable to address this issue until the dog policy was up for review (6 yearly). Preservation of dunes helps maintain infrastructure and restoration goals. Consultation on this issue is ongoing. Aware that there are a lot of conversations. Council is keen to listen and to take back concerns.

Paul Andrews - the Council is balancing the impact of dogs on indigenous wildlife. A lot of challenges for the preservation of the dune and the options all mean significant trade-offs. The council recognises that a large number of people own dogs but also many that don't - one option is to conduct a targeted survey.

Are dogs having a negative impact on the dunes? It is small and steep, weather events impacting. Overall the dune has improved but not without significant effort by community - weeding and planting. Hard to quantify. One of the issues is dogs going to the toilet there. Wildlife, especially penguins - none in this area - may not be a suitable habitat - however possibility of wildlife returning if there weren't dogs.



# Key points from discussion:

- There are also oystercatchers that need protecting.
- Dunes around the surf club also need protection but are more impacted by weather events.
- Question around impact on swimming on the Western side. The Western side of the Bay is more challenging for swimming. Eastern side is the safest side for swimming and better sand. The Western channel is narrower.
- Possibility of the West side being an on-leash area?
- A change in the policy that people carry a dog poo bag is also included in this review but there is difficulty enforcing this (although this regulation will allow potential enforcement over what is currently present).
- No fence around the @dog park on the other side of the road on Reef street this could be made more dog friendly as an alternative to the Beach.
- Comments on the methodology of "no preference" in a survey selecting this can distort results if the reason for no preference is not provided, i.e. there was no option to tick 'not applicable' so all who don't use a certain area are likely to have ticked 'no preference' with a distortion of what appears to be the consensus on the proposals.
- One option is to ban dogs from the beach and accept they need to be exercised elsewhere.
   Andrew responded that we do allow dogs access to the beach due to demand an increase in dog ownership and increased inner-city living. This is why we review dog policy. Also, human health outcomes are associated with dog ownership. Dogs enjoy the water. The Council decides when & where access is appropriate and periodically reviews the policy.
- Question about whether WCC will enforce the restriction of time on the beach. Andrew
  responded that residents need to be realistic about enforcement funded through dog
  registration fees. Currently the enforcement is Mon to Fri and may need to extend this.
  Enforcement cannot be seen as the most effective and costly way to change behaviour.
- Question whether there is an opportunity to increase awareness of the specialness of the
  area, and link to the marine reserve, invite people to keep people to keep their dogs off this
  area. Giving people a nudge. It was noted that Island Bay beach is popular beyond the local
  community.
- Question whether there is a possibility to provide an escalation pathway in the policy asking people to respect the dunes and if no improvement following monitoring then move to restricting access.
- Possibility of inviting a dunes expert to come to a community meeting to help explain why this
  area is so important from a conservation perspective.
- There are various options dogs on leash, dogs south of the dunes
- Laurie emphasised that this proposal is still open and feedback welcome.
- Oral submissions are really helpful

Submissions close at 5pm on 18 October.

Council thanked everyone. Committee thanked Council members for attending.

# Berhampore and Newtown walking/cycleway/parking proposal

Submissions closed on Sunday. It was open for 4 weeks.

It was commented that the sports clubs at Wakefield Park had engaged in productive discussions with the transitional cycle network team and where generally pleased with the proposal. Aiming for net zero parking loss, with additional parking on Dover street and the bus turn around zone.

A resident voiced concerns about WCC investment in cycleways and loss of parking.

## **Community Fund Applications**

The \$100 grant for the Compassion Festival is not enough - need \$500. The fund has \$500 remaining so cannot support investment of \$500. The Committee agreed that the \$100 grant could be spent on pamphlets. Sonya to advise the church.
